I. Call to Order

• The meeting was called to order by Dethloff at 6:04 p.m.

II. Public Comment Period

No citizens presented comments.

III. Water Conservation & Heavy Equipment Operator Position

- Benson presented the job description for the new position of Water Conservation & Heavy Equipment Operator.
- Benson explained the District has experienced an 18% growth rate in the last five years and felt it
 was essential to have a position that would manage strategic water operations, projects, and
 provide supervisory responsibility. The position would not fully be based on certification, but
 other essential functions needed.
- The position would not only perform the duties of a water and wastewater / heavy equipment operator, but would also plan, develop and implement long range projects to meet community demands. Promote actions that result in long-term increases in the productivity of water supply. Conservation strategies including technological and behavior changes, education, and regulatory actions are emphasized. Implement the Water Efficiency Plan, measures its' effectiveness and completes necessary reports. Recommend policies to satisfy water supply needs without compromising desired water service. Responsible for enforcing water use regulations.
- The Board questioned if the position was created for an individual and Benson assured that is was not. The position would be created to capture an individual that would not only perform the

- duties of a water and heavy equipment operator but would also be required to hold the highest certification and utilize other advanced skills sets the District needed.
- The Board felt the position was needed to help assist the District Manager, future projects, as well as manage water operations. The Board felt the position title needed to be Water Operation Coordinator & Heavy Equipment Operator to represent the essential functions of the position.
- The position would be offered to the current staff as well as advertised for two weeks to capture the best candidate.
- The position would require a CDL or obtain certification within a year, a State Operator D License or obtain certification within six months, a State Operator A License or obtain certification within four years, and acquire water ORC responsibilities.

MOTION by Bellamy and seconded Hein by to approve the Water Operations Coordinator & Heavy Equipment Operator position. Motion passed unanimously.
